- Nifty to trade with a resistance of 11170.

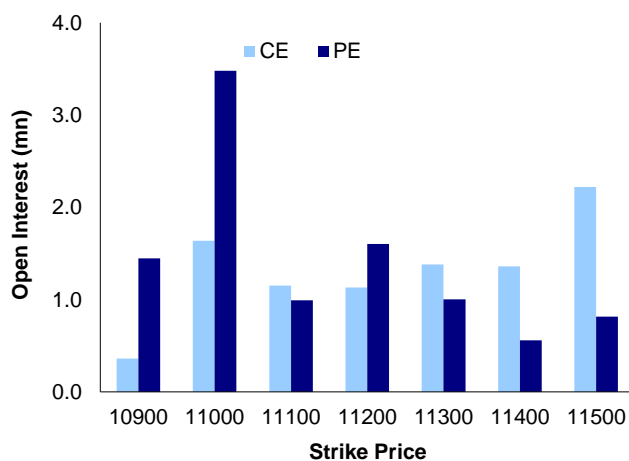

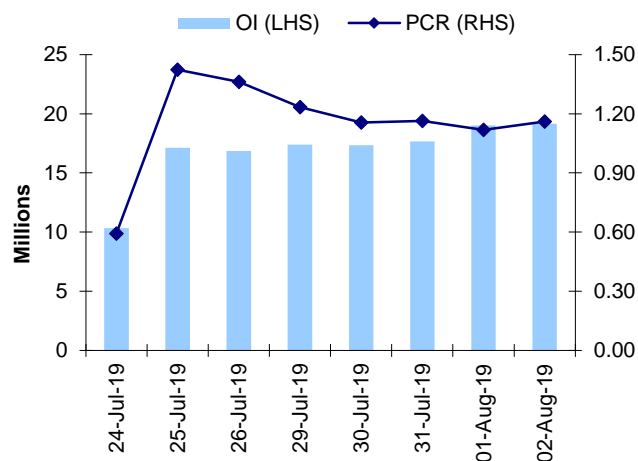
