- Nifty to trade with a support of 10250.

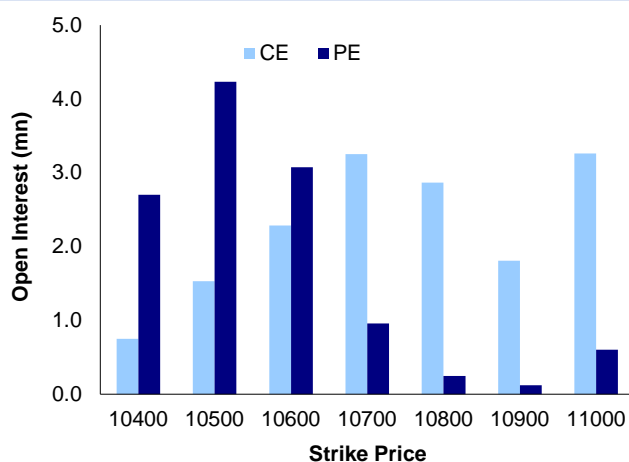

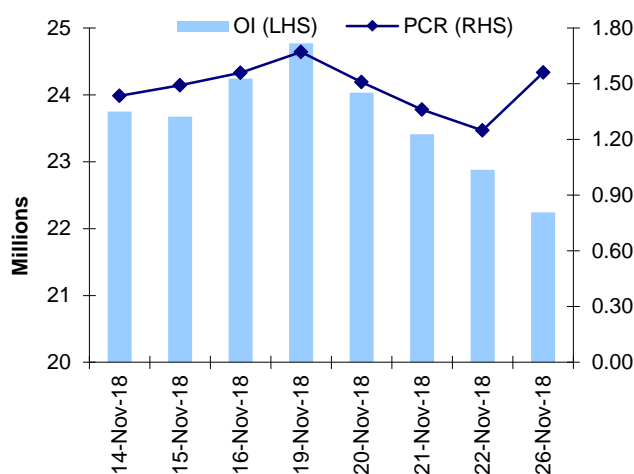
