1. According to media reports, I-T department has decided not to release INR 20K crore refunds claimed by corporates and public sector units for the financial year 2016-17, citing reasons such as discrepancies in the credit of tax deducted at source (TDS), carry forward losses, and pending tax demand for the previous years.
2. Finance Minister Arun Jaitley said on Thursday that the interim Budget, to be presented on February 1, will be within the existing conventions. Its contents, however, will be dictated by economic compulsions and realities of the day. He also hinted that these very economic realities could decide whether the government sticks to a fiscal consolidation roadmap or not. He admitted the farm sector has been facing challenges due to rise in production and a fall in food prices.
3. Union minister Jayant Sinha on Thursday said the "most likely" outcome of the ensuing Lok Sabha elections is that India may not get a strong and stable government.

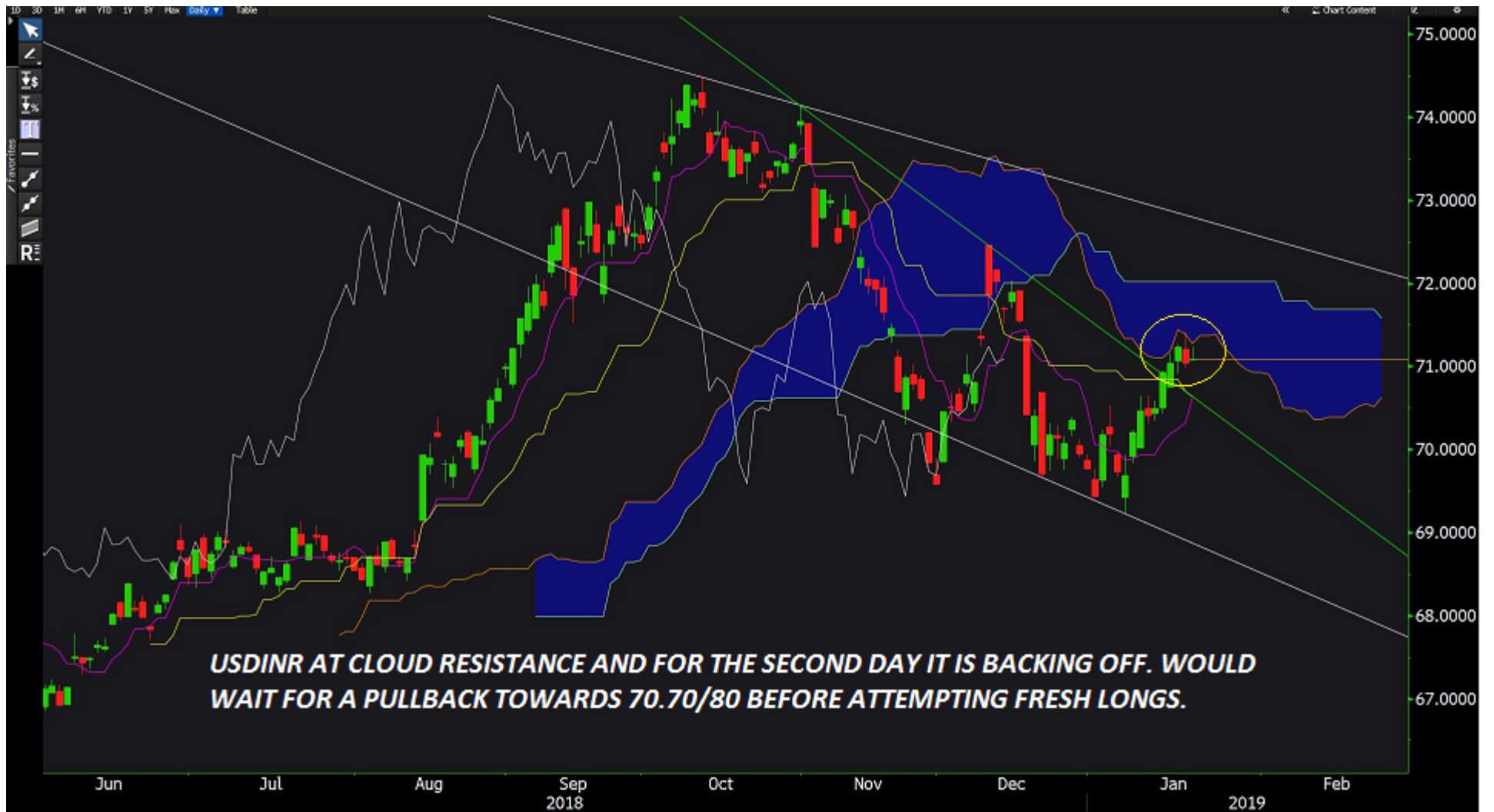
FX VIEW

Yesterday, implied volatility of front month options did not rise with the upward movement in the spot Dollar and also the spread between onshore offshore futures and forwards were coming-off. It was sign that the short covering demand was waning. Once, the long bond yields fell by 5/6 bps and Euro and GBP rallied, USDINR dropped from 71.40 to 70.98. The larger picture has not altered. After a relentless rally from the lows of 69.22, there was a case for a corrective pullback. Global markets are still in risk-on mode and the short covering demand has waned, hence there is not much force left for USDINR to keep pushing. Hence it is good to see the correction unfold. The hints dropped by various government officials indicate that GoI is looking at expansionary fiscal policy going into the national election, as they fear a risk of a hung Parliament. Therefore, political risk and fiscal risk will keep the domestic risk premium high on Rupee. Once the global risk aversion returns, USDINR can rally quite sharply. As of now, we expect USDINR to build a base below 71.00 levels on spot, as long as the global markets remains on risk on mode. There multiple layers of support between 70.00 and 71.00 on spot. The support levels are 70.70/80 and 70.30/50 on spot.

TECHNICAL VIEW:

For the day, we would look to buy as long as the pair holds above 70.90 on spot. Resistance remains around 71.40 and 71.50/55 on spot. GBPINR is also a buy on decline as long as the pair holds above 90.00 on spot.
