#### Currency pair ==> USDINR spot

View = Prices are moving around in gaps without any sustained trend. Wait for trend to emerge. Support is between 70.80/90 on spot and resistance around 72.00 on spot.

Trade = On the sidelines. Short volatility strategies via USDINR options can be considered.

#### Currency pair ==> GBPSUD spot

View = Intermediate trend remains bullish.

Trade = Buy between 1.2420/40 TP 1.2550/1.2600 SL 1.2370

### MACRO VIEW

- Yesterday oil shock rocked Indian equity markets as it closed 1.7% lower on frontline indices. Selling was broadband. Rupee too touched an intra-day low of 71.98 but suspected heavy intervention brought the pair back below 71.80 by close. GOIsec 10 year rose 2bps at 6.73%.
- Overnight risk-off flipped to risk-on as oil prices collapsed. US equity indices closed marginally higher. US 10 year remained flat around 1.81% as traders await Fed decision tonight.
- US Fed is expected to lower rates by 25 bps tonight. The US economy has seen improvements and deterioration since the July meeting. Retail sales growth slowed, job growth moderated, manufacturing activity eased and consumer sentiment soured. However inflationary pressures have been steady, wage growth quickened and service-sector activity accelerated. It will be the guidance which will move Dollar and rates. If they sound hawkish, then Dollar can bounce back against low yields like Euro and JPY.
- Asian equity indices are trading mixed. SGX Nifty is suggesting an open of 50 points higher for onshore Nifty. Asian currencies are gaining against USD, especially USDCNH and USDINR NDF. USDCNH is now down to 7.08, trading below USDCNY. USDINR NDF spot reference is quoting 71.40.
- Brent crude oil futures have fallen from 70 to 64 now after Saudi Arabia's energy minister said the Kingdom will restore lost oil production by the end of the month. This is one of the shortest duration oil shock. Gold has bounced from under 1500 dollars an ounce to now 1510 on the active month futures on the CME.
- Pound Sterling's recovery rally against the USD and Euro are still alive. GBPUSD rallied 100 pops from 1.2400 to 1.2500 overnight. We are holding long position in GBPUSD, which we may exit at the open. The bone of contention in the Brexit negotiations has been the Irish border issue. Some light at the end of tunnel is being seen as UK and EU may be able to reach a compromise on the matter. This news will continue to drive GBP pairs higher. Therefore we would look for counter trend corrections to enter fresh longs in GBPUSD.
