- Nifty to trade with a support of 14032.

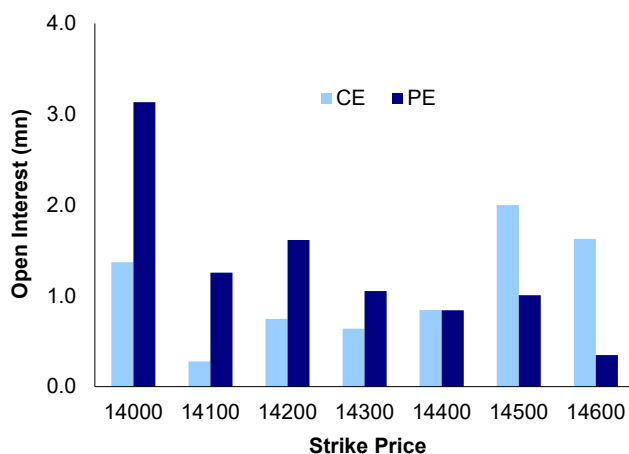

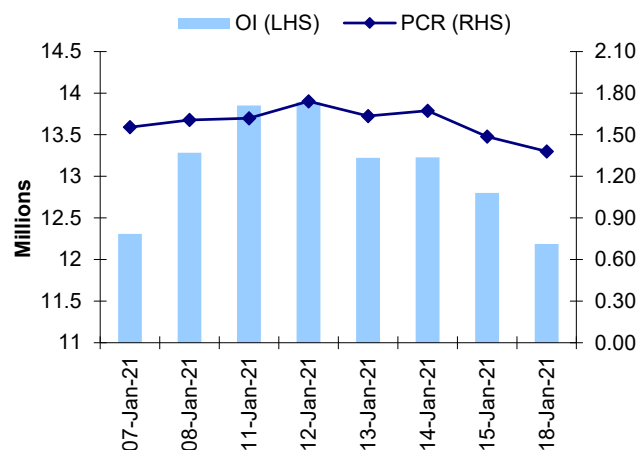
