Key Highlights:

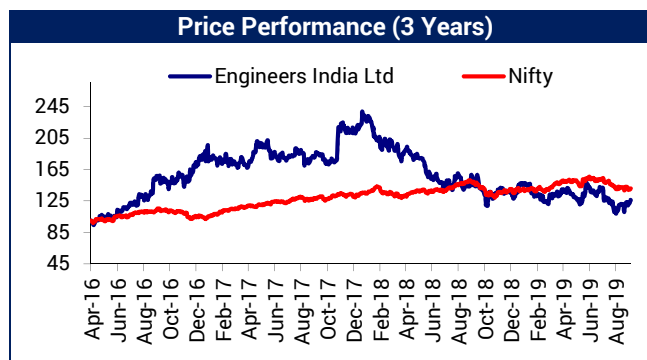
- Engineers India Ltd (EIL) is a leading global engineering consultancy and EPC company. Established in 1965, EIL provides engineering consultancy and EPC services principally focused on the oil & gas and petrochemical industries. The Company has also diversified into sectors like infrastructure, water and waste management, solar & nuclear power and fertilizers to leverage its strong technical competencies and track record.
- EIL has developed an enviable track record in design, engineering and execution of cross-country pipelines for transportation of crude oil, refined petroleum products, natural gas and LPG across diverse geographies and demanding terrains.
- Management reiterated long term positive outlook on the domestic order inflows driven by 1) brownfield expansion of refineries (including small refineries with capacity of less than 3 mmtpa) 2) set up & integration of petrochemical plants with existing refineries 3) greenfield refinery expansion- including Maharashtra Refinery.
- Domestic market expected to remain buoyant in the long term driven by the ambitious target set by Ministry of Petroleum and Natural Gas of expanding India's refining capacity to 440 MMTPA from 247 MMTPA currently by the year 2040. (Source: www.thehindubusinessline.com)
- EIL's order backlog, reported at Rs. 114 bn at the end of 1QFY20 (+58% y/y).
- Order inflows remained robust in 1QFY20 at Rs. 9.4 bn. Management has guided for revenue growth of 15-20% for FY20. We note that the order pipeline remains strong, potentially arising from greenfield/brownfield expansion by leading refineries.
- In order intake, the management expects to secure orders worth Rs. 18 bn each in FY20E and FY21E respectively. The management has guided for EBIT margin of 23-30% in consulting and 5% in LTKS projects.
- We value FY21 core earnings of Rs. 5.8 per share (excluding other income adjusted for tax) at PER 15x (22x earlier) and add back cash per share of Rs. 50 per share in FY21. Thus arriving at a target price of Rs. 137 (Rs. 147 earlier).

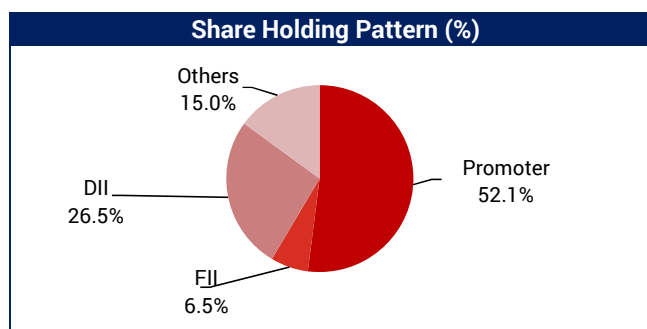
