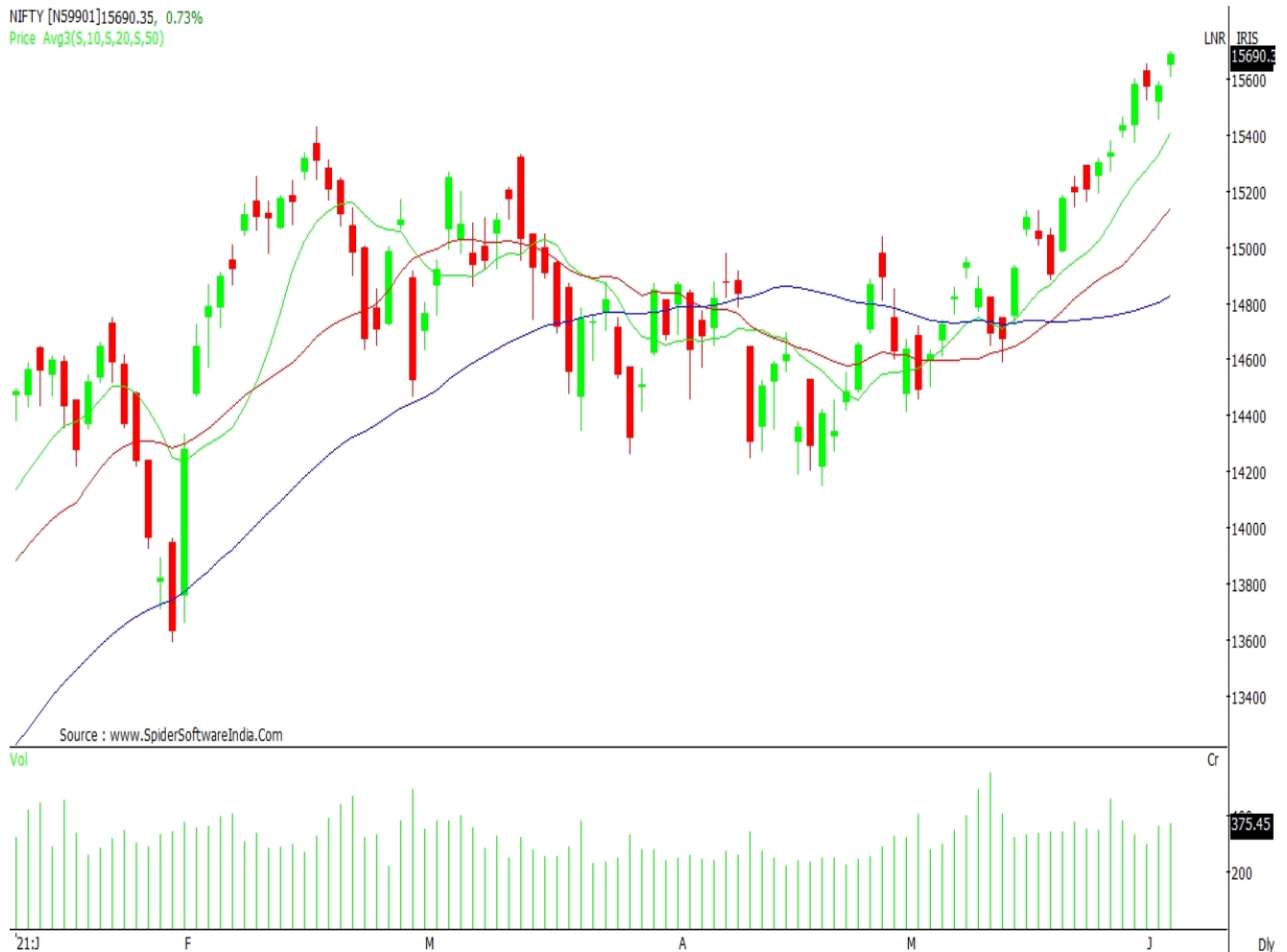

► Market Analysis

Nifty/Sensex Daily View: The Nifty is moving towards 16,000, setting a new record in a row. The Sensex is also preparing to reach its peak 52517. On Thursday, Titan, ONGC and LT helped bring the Sensex and Nifty to higher levels. The Nifty has once again formed a bullish continuation today. Today, is a day of the credit policy and its outcome could be between 9.40 am and 10 am. For the Nifty/Sensex 15550/15600 (52000/52800) can support, however, the resistance is close to 15750/15800 (52517). 15770/15780 (52517) can be a big hurdle. For the Bank-Nifty resistance would be at 35900 and at 36400 levels. Supports would be at 35250 and at 35000 levels. Don't act aggressively in a rising market. Buy on dips or stay stock specific. The focus should be on FMCG, FINANCIALS and Auto stocks.
