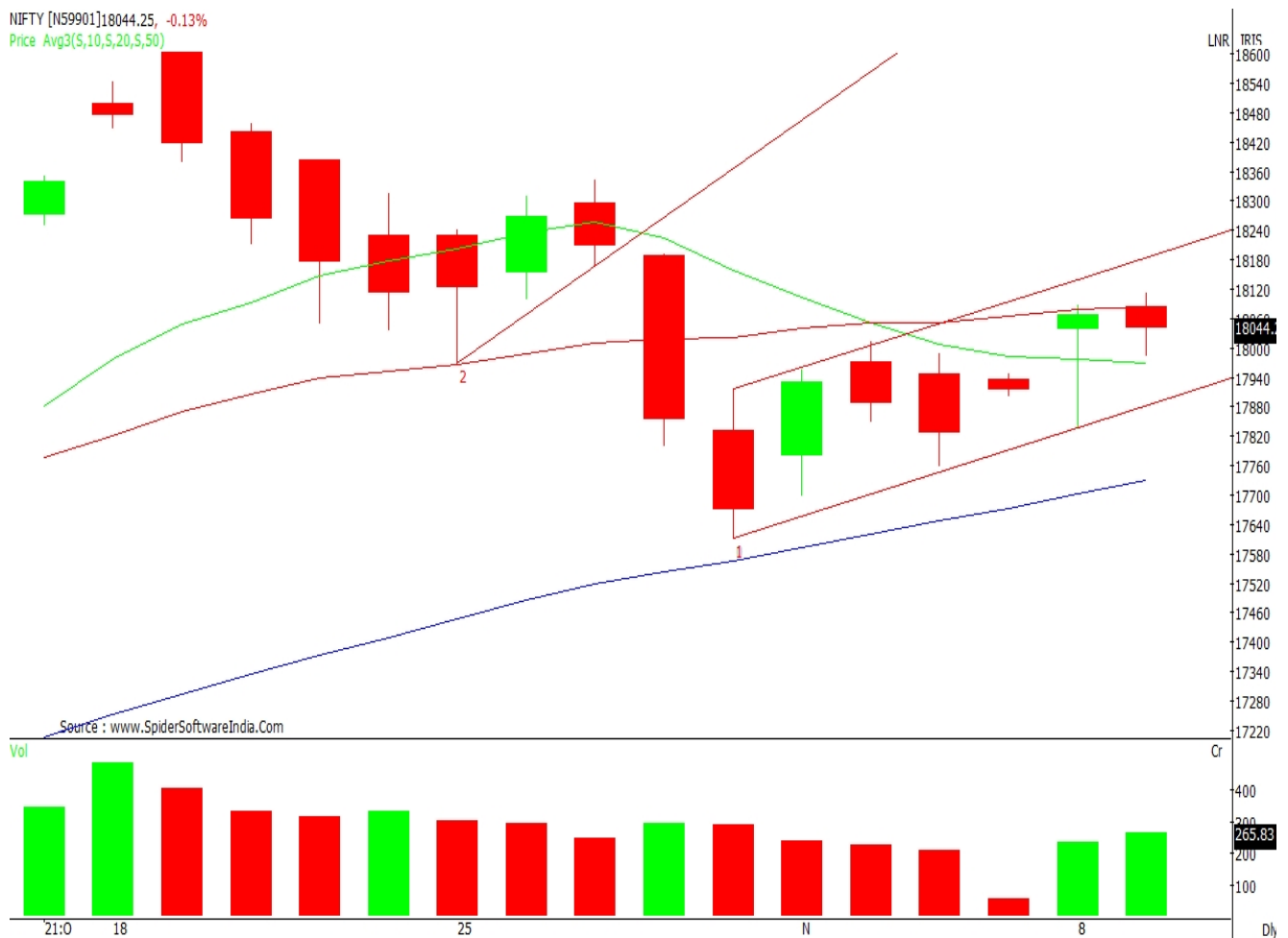

► Market Analysis

Nifty/Sensex Daily View: The strategy of buying on dips is delivering decent returns to short term traders but the positional traders are stuck with the positions and they will get the exit if Nifty crosses 18130 levels decisively.

In case the Nifty breaks the level of 17950 then the chances of re-testing 17800 would turn bright, however, while looking at the stock-specific performance, we are of the view that the Nifty is ready to surpass the levels of 18130. Above 18130 levels, the Nifty would travel to 18350 levels with a minor resistance at 18190.

FII's are selling in the cash segment and on Tuesday, they took a bearish stance on the FNO sector with a short-term outlook that needs to be noted.
