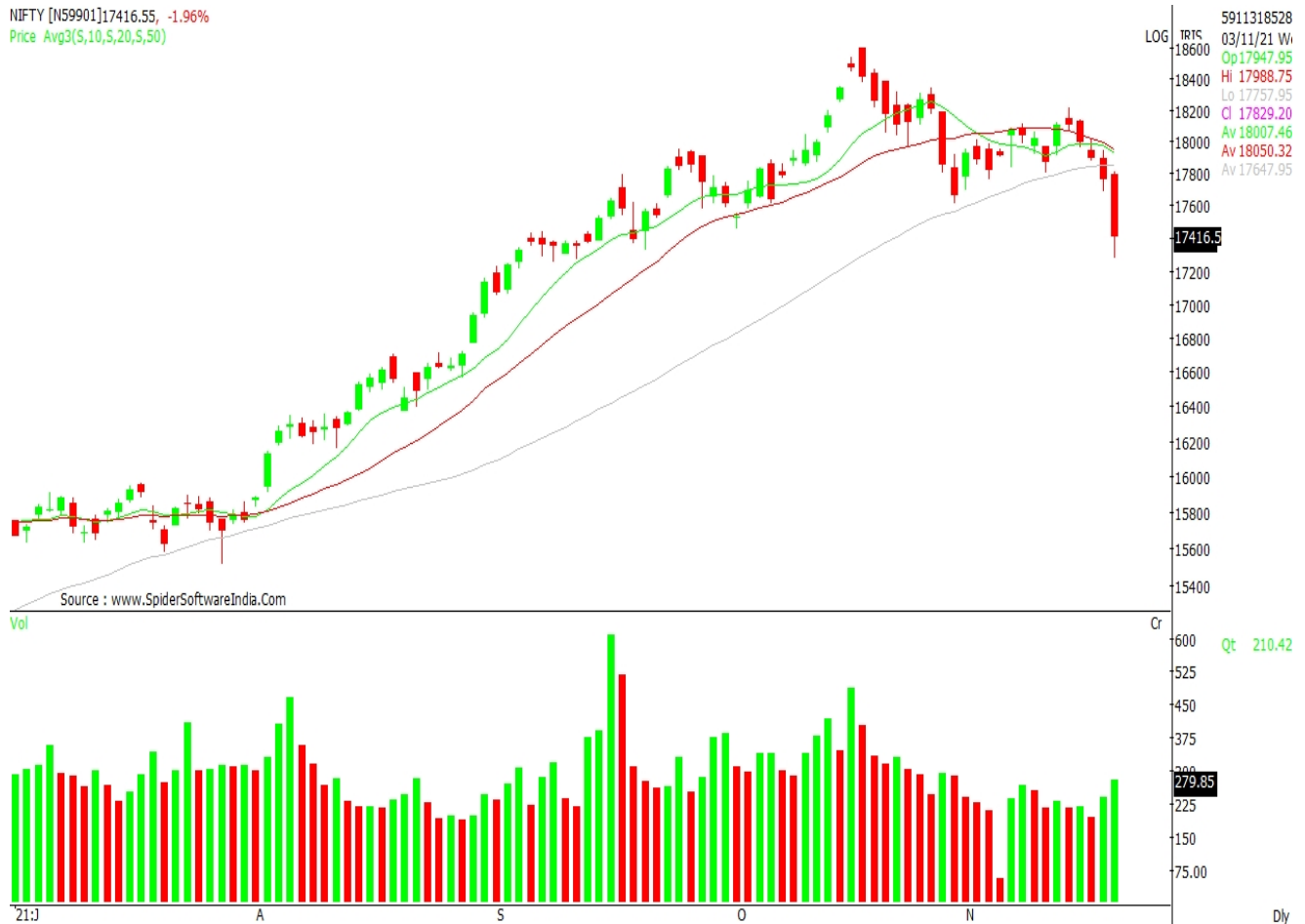

► Market Analysis

Nifty/Sensex Daily View: It was not at all expected that the Nifty will touch the level of 17300 on Monday itself, but unfortunately, this is how the stock market works and whenever we are trading in the market we need to keep an eye on the important levels and the stop loss level.

Since the Nifty has broken 17600, the next base would be between 17250 and 17150. If the domestic news flow turns further negative, we can also see the 16900 level, however, we think it should last a short time. It is advisable to buy at 17250, 17100 and 16950 levels with a medium-term view. At the top, 17600, 17750 and 17850 will be the major hurdles. Be stock specific; keep adding same strong companies at major supports.
