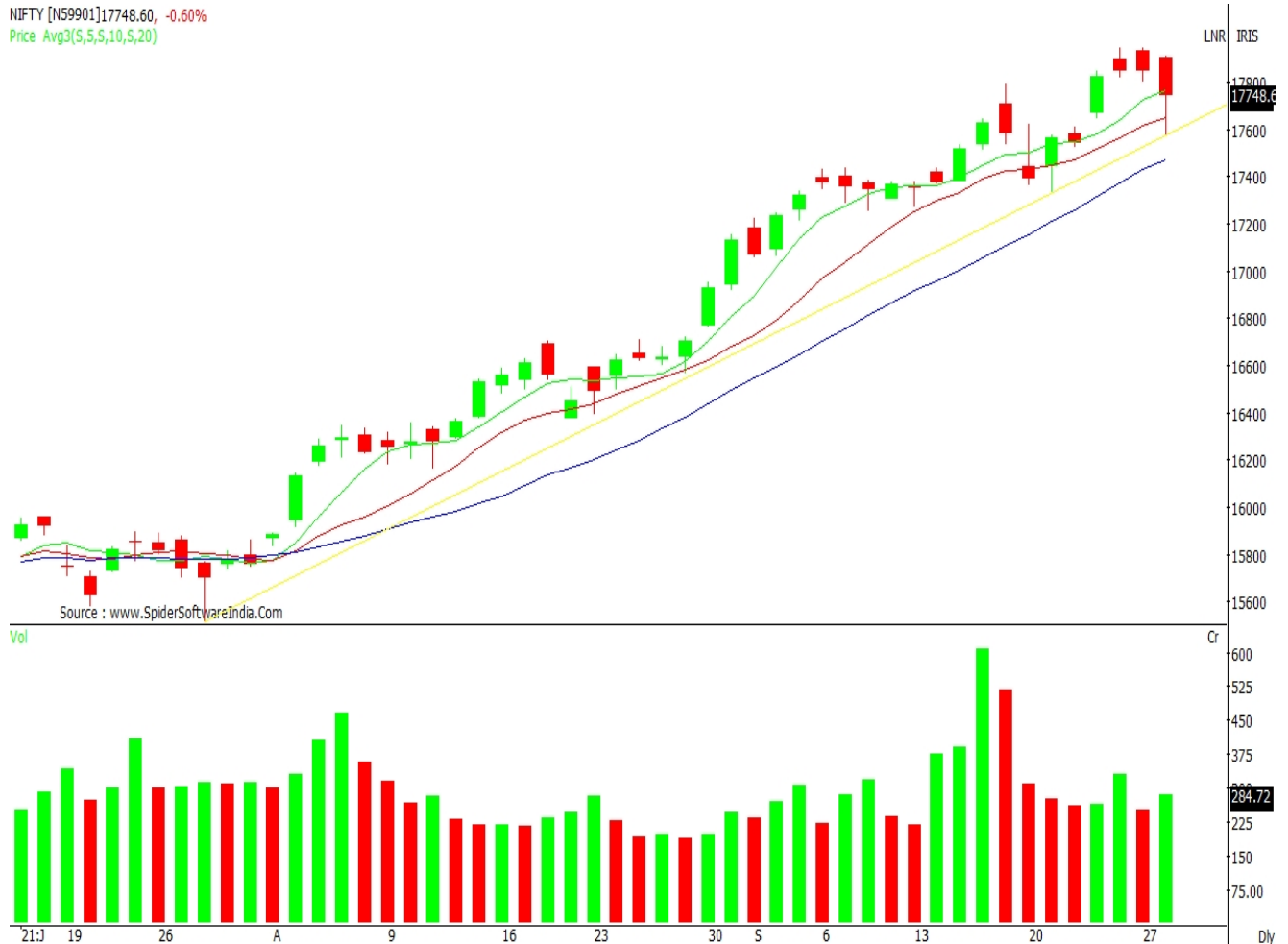

► Market Analysis

Nifty/Sensex Daily View: Due to the monthly and quarterly expiration day of the FNO Contracts, we may face major volatility today.

Against the backdrop of stable global signals, the market remained in the broader trading range throughout the day. Traders were also wary before the monthly and quarterly expiration of F&O contracts. However, on today, again we expect an expansion of the trading range in the market. The Nifty is finding resistance at the 17790/17800 level and beyond that, we would see short covering up to the 17860/17880 level. Below the 17690 level, the chances of reaching 17600 would be bright; however, on Tuesday's lowest level dismissal (17570) we could have an immediate decline at the 17500 level.

Based on FNO's statistics, FIIs are having short positions in the market against retailers. Based on that, we need to keep an eye on the 17800 and 17570 market boundaries as they invite unwinding of call or put options.
