► Market Analysis

Nifty/Sensex Weekly View:

Last week, the market saw volatile activity, after a roller coaster activity Nifty ended at 17956 while Sensex closed at 60261. Sectors saw buying in IT and metal stocks. The IT index was the top gainer, rising 3.5 percent, while consumer and select FMCG stocks booked profit at higher levels. Technically, last Friday the market once again took support near 17750/59650 (which is a double bottom support level) and reversed sharply. However, the short-term formation remains to the downside. Furthermore, on the weekly charts, the index has formed a long-legged Doji candlestick formation. The pattern reflects the indecision of buyers and sellers. We believe that the 100-day SMA (Simple Moving Average) or 17900/60100 will act as a holy support level for the next few trading sessions.

Above which the pullback formation is likely to continue, the index may rally towards 20 days SMA or 18075/60800. The uptrend may continue further, which may lift the index to 18200/61100. On the other hand, a fresh round of selling is possible only after 17750/59600 breaks below this, the index may slide towards 17676-17500/59300-58900.

41500 is an important support level for Bank Nifty below which it may witness further losses towards 41000/40900 levels. On the upside, 42700 and 43000 will be hurdles for the day.
