## ► Market Analysis

### Nifty/Sensex Weekly View:

The benchmark indices saw volatility in the past week, with Nifty ending at 18027 after a roller coaster ride, while Sensex closed at 60619. As a result, the Media Index dropped over 4 percent. During the week, the market bounced sharply and after a long period, it managed to trade above the 20-day SMA (Simple Moving Average) level, which is broadly positive. However, once again it saw some profit booking near 18200/61000. We are of the view that 18000/60500 or the 20-day SMA will act as a holy support area in the near term.

Above 18000 levels, the index may retest 18150-18200/60900-61000 levels. On the other hand, a break below 18000/60500 is likely to intensify bearish sentiment. On the dismissal of the 18000/60500 mark, the market would move towards 17850/60100 or 17750/59900. Based on the options statistics the market is turning oversold. The monthly PCR is at 0.70, which will offer buying opportunities in select strong companies at current levels and on dips.
