## ► Market Analysis

### Nifty/Sensex Weekly View:

In the past week, the benchmark indices witnessed a stellar rally. The Nifty closed with a gain of 4.10 per cent while the Sensex rose nearly 2000 points. Among sectors, strong buying was witnessed in PSU banks, IT and metal stocks. Among sectors, the PSU Bank index rose over 8 per cent, while some profit-booking was seen in select pharma stocks despite strong momentum. During the week, Nifty/Sensex successfully crossed the short-term resistance of 16300/54700, it also cleared the 100 days SMA (Simple Moving Average) level and managed to close above the same.

Technically, the index is trading near an important resistance level after a promising uptrend rally. The short-term formation is bullish, but due to temporary overbought conditions, we may see some profit booking at higher levels. Now 16800 and 16950/56300-56800 would act as immediate resistance zones for the positional traders. On the other hand, 16480-16350/55500-55300 could be key support levels for positional traders. The market is likely to consolidate before rallying further, so buying on downsides and selling on rallies can be ideal strategies for short-term traders.
